Administration and Account Sections of the Directorate are functioning as per the prescribed rules & procedure of Govt. The Registration of Births & Deaths is done by the local bodies Municipal Corporation of Delhi, New Delhi Municipal Council and Delhi Cantonment Board as per the provisions of Registration of Births and Deaths Act, 1969 and Delhi Registration of Birth & Death Rules, 1999 as amended from time to time.

Surveys like Socio-Economic survey, Economic Census are conducted as per the guidelines issued by N.S.O. and National Sample Survey Office of the Ministry of Statistics & Programme Implementation, Govt. of India.
