## **P R E F A C E**

The present report “Index of Industrial Production 2020-21 is brought out by this Directorate as per the new base year 2011-12. This report is the fourth in new series with base year 2011-12 presenting the physical growth of the registered manufacturing sector of Delhi for the year 2020-21. The methodology used for compilation of Index of Industrial Production is devised by National Statistics Office, Ministry of Statistics & Programme Implementation, Government of India.

The State Level IIP serves as a vital quantitative indicator of trends in the registered manufacturing segment in the short term. This is a useful and instant tool in the hands of Planners and Policy makers to gauge the health of the industry in short run as the final statement on this sector comes with publication of results of Annual Survey of Industry with a time lag of 2 Yrs. The index of Industrial Production also serves as a deflator for estimation of industrial production at constant prices. This report gives trends in index month-wise, industry division-wise and broad sub sector-wise.

This publication was brought out by the ASI /IIP unit of this Directorate under the guidance of Sh. C.K. Dutta, Jt. Director and under the active supervision of Sh. L.L. Meena, Dy. Director, Sh. Sunder Lal, Assistant Director, Sh. Parveen Chawla, Statistical Officer. Mrs. Binni Choudhary, Sh. Pradeep Kumar, Sh. Sachin, Sh. Pardeep kumar Yadav, Sh. Rohan Pokhrel, Sh. Naveen Rawat, Sh. Robin Verma and Ms. Shilpi Sinha Statistical Assistants made strenuous efforts in collection of data from the industrial units. **EXECUTIVE SUMMARY OF INDEX OF INDUSTRIAL PRODUCTION (IIP)**  
**FOR THE YEAR 2019-20**

- i. Index of Industrial Production (IIP) measures the relative changes in the volume of production in non-agricultural commodities and is an effective tool to measure the short-term changes in industrial production. The methodology and process of collection of data, selection of sample and compilation of IIP are as per the guidelines of Industrial Statistics Wing, MOSPI, Govt. of India.
- ii. The Annual Report 2020-21 on Index of Industrial Production (IIP) in Delhi with base year 2011-12 has been prepared based on the production data received from 134 manufacturing units and one Electricity Unit in Delhi being engaged in production of 90 different categories of items.
- iii. Assigned weights for Manufacturing and Electricity Sectors are 586.1 and 413.9 respectively. Total weights is taken as 1000 and apportioned in two industrial sectors, namely, manufacturing and electricity as per their contribution in state Gross Value added in the base year 2011-12.
- iv. Average monthly Index of Industrial Production, FY 2020-21 has indicated a decrease of 10.45% from 157.34 in the year 2019-20 to 140.91 in 2020-21. The corresponding decrease in All India level is reported as 8.45%.
- v. The manufacturing sector in Delhi has registered a decline of 9.15 % in IIP from 156.66 to 142.32 during the year 2020-21 as compared to 9.57% decrease in All India level.
- vi. Whereas, IIP in Electricity Sector has indicated a decline of 12.26% from 158.31 in FY 2019-20 to 138.90 in FY 2020-21. The Corresponding decrease at All India Level was 0.50%.
- vii. 5 major sectors at NIC two digit level, namely, Manufacturing of motor vehicles, trailers and semi-trailers (NIC-29), Manufacture of machinery and equipment n.e.c. (NIC-28), Manufacture of food products (NIC 10), Manufacture of furniture (NIC-31) and Manufacture of wood and of products of wood and cork, except furniture; Manufacture of articles of straw and painting materials (NIC-16) have shown increase in the year 2020-21 as compared to 2019-20. The increase in these five sectors is estimated at 30.65%, 13.94%, 1.45%, 44.53% and 20.36% respectively.

- viii. Three major product groups, namely, 'Manufacture of wearing apparel (NIC-14), 'Manufacture of Computer, electronics and optical products (NIC-26) and Manufacture of fabricated metal products' except machinery and equipment (NIC-25) have shown sharp decline in IIP during FY 2020-21 by 29.70 %, 33.69% and 30.54% respectively.
- ix. As per used based classification of products, one group, i.e., Intermediary goods' has recorded growth in IIP by 23.13% in FY 2020-21. All the other groups namely Primary Goods, Capital Goods, Consumer durable Goods and Consumer Non-durable goods have shown decline by 11.98%, 23.90%, 22.71% and 1.88% respectively.

# CHAPTER ONE

## INTRODUCTION

Index of Industrial Production (IIP) is of immense use for measuring the industrial development of a State/Territory. The index indicates relative changes over the time in the volume of production in non-agricultural commodities and it is an effective tool to measure the trend of current Industrial Production. Index of Industrial Production is a single representative figure (an abstract number) to measure the general level of Industrial performance in an economy. It measures the short term changes in the volume of industrial production during the given period w.r.t. chosen base period. The figure (s) used extensively by Govt. Department, Industrial Association, Research Industries, and Academicians etc. for research and policy formulation purposes. At the National level, the index of industrial production is being compiled by the National Statistics Office, Govt. of India and is released on monthly basis. This index, however, does not serve the purpose for evaluating the industrial growth of a State/Union Territory. Therefore, the Directorate of Economics and Statistics has been compiling/releasing the monthly indices of industrial production for the National Capital Territory of Delhi on quarterly/annual basis since 1976.

In the first series, 1970 was the base year for compiling the IIP both by the Central Statistical Organization & Directorate of Economics and Statistics. The base year was, however, shifted to 1980-81 in the year 1987 as per recommendations made by the Working Group so as to accommodate the latest structural developments that have taken place in the industrial profile during the seventies. Accordingly the Directorate of Economics and Statistics also adopted the base year of 1980-81 since 1989-90.

The main lacuna of State Level Index of Industrial Production (IIP) is that the Indices lacked comparability due to use of different base year, periodicity & data sources etc. The need for a comparable state level IIP to facilitate studies on the state-wise performance of Industrial sector has been felt for quite some time. Accordingly a Technical Advisory Committee (TAC) was constituted in June, 1995 to formulate guidelines and methodology for preparation of comparable IIP. On the basis of recommendations of TAC it was decided to bring forward the base year from 1980-81 to 1993-94. Subsequently the base year was revised from 1993-94 to 1999-2000 and then 1999-2000 to 2004-05, now it has been shifted to 2011-12 to compile comparable IIP.

Accordingly, as per initial guidelines of NSO, Govt. of India in July 2015, the item basket & weighting diagram were prepared after intensive field work. The Index for the period of 2020-21 is presented in this report with the new base year 2011-12.

In this publication time series IIP Indices are presented w.r.t. manufacturing and electricity sectors. Indices of industrial production has also been presented broad industry group wise at NIC 2-digit level and also Use-based categories of products.

## **CHAPTER TWO**

### **METHODOLOGY**

The specifications with regard to the drawing of the item basket and weighting diagram as recommended by the Working Group have been elucidated below as guidelines for framing the IIP for States/ UTs with base year 2011-12.

#### **1. ITEM BASKET**

The scope of IIP constitutes the mining, manufacturing and electricity sectors. However, in absence of any mining activity in Delhi only manufacturing and electricity sectors are considered. This time item basket for manufacturing sector were selected and provided to each state/UT by National Statistics Office (IS-Wing), Kolkata. In case of the Manufacturing sector, the basis for selection of item basket is the GVO (Gross value of Output) figures for products from the Annual Survey of Industries (ASI) 2011-12. The methodology used by NSO for the construction of state-level IIP is as below:

- i. Using the ASI 2011-12 production data pertaining to NIC 10 to 32 the first job was to remove 'other products and by-products' from all the industry groups after re-distributing their values over the rest of the products occurring in the respective industry groups (NIC 3 digits).
- ii. Subsequently, each item (7-digit NPCMS) is placed in alignment with a particular industry group (at NIC 3-digit level) in which the product's maximum GVO occurred, leaving with a unique product description, its NPCMS code, its maximum value occurring over the complete dataset and the industry group pertaining to the maximum value.
- iii. From the list stated above, the product descriptions at the 7-digit level of the NPCMS corresponding to not-elsewhere-classified (n.e.c.) products are removed and the contributions of all such products in a particular industry group are re-distributed among the non-'n.e.c.' products. This is done to avoid ambiguity of description as well as to facilitate easy identification and collection of data pertaining to these items from the factories.
- iv. The list of products thus obtained is arranged in descending order of value of output within each 3-digit level of NIC and then starting from the highest contributor, all the products are selected till total value of output of the selected products becomes at least 80% of the total value of output at each 3-digit level.

#### **2. WEIGHTING DIAGRAM**

The methodology for deriving the weighting diagram for State IIP is detailed as under:



- i. Weights at sector level: In allocation of weights, total weight is taken as 1000 and this is apportioned in two industrial sectors namely registered manufacturing and electricity as per their contribution in State GVA.
- ii. Weights at 2-digit level: The weight for the manufacturing sector is distributed at 2- digit levels of NIC in proportion to the total GVA in each 2-digit level of NIC for the State from ASI 2011-12 data.
- iii. Weights at 3-digit level: Weights in each of the NIC 2 digit level is then distributed to NIC 3 digit levels in proportion to their respective GVA figures for the State from ASI 2011-12.
- iv. Weights at product/item group level: NIC-3 digit level weights are then distributed to selected products/ item groups in proportion to their GVOs for the State from ASI 2011-12.

### **3. SELECTION OF FACTORIES**

Once the item basket for a State/ UT has been derived, the list of factories under an item is selected by considering complete list of factories having a substantial combined/aggregate share (at least 50%) of production of the item in the state/ UT from ASI 2011-12 data.

### **4. COLLECTION OF DATA**

For preparation of the current series of Index of Industrial Production (Base Year 2011-12), Production data w.r.t. 90 items was collected from 135 factories/units for the financial year 2020-21 through intensive field visits, by post and online arrangement. For some items, production is taken in terms of value as specifications are heterogeneous in nature for those items. The items include leather garments, wearing apparel, corrugated box, water-proof footwear and books.

To overcome the problem of delayed response/non-response the following procedure has been adopted for estimation of production of such non-responding units on monthly basis. Suppose out of say “n” units selected for a particular month,  $n_1$  units give timely response and the remaining of  $n_2$  ( $n-n_1$ ) units might not submitted the return for the particular month in time. The production of item of these  $n_2$  non-responding units has been estimated either on the basis of the trend in production of the  $n_1$  responding units or average production of last three months for a particular item for which data has not been received for the month under report, is taken under consideration.

### **5. CALCULATION OF INDEX:**

The Index of Industrial Production is calculated as Weighted Arithmetic Mean of the production relatives in respect of selected items mathematically.

$$I = \frac{\sum R_i \times W_i}{\sum W_i}$$

Where I is the index

$R_i$  is the production relative of  $i^{\text{th}}$  and  $W_i$  is the weight allotted to it. 12<sup>th</sup>

The production relative ( $R_i$ ) of  $i^{\text{th}}$  item for the month has been calculated by using the following formula:

$$R_i = \frac{P_{ic}}{P_{io}} \times 100$$

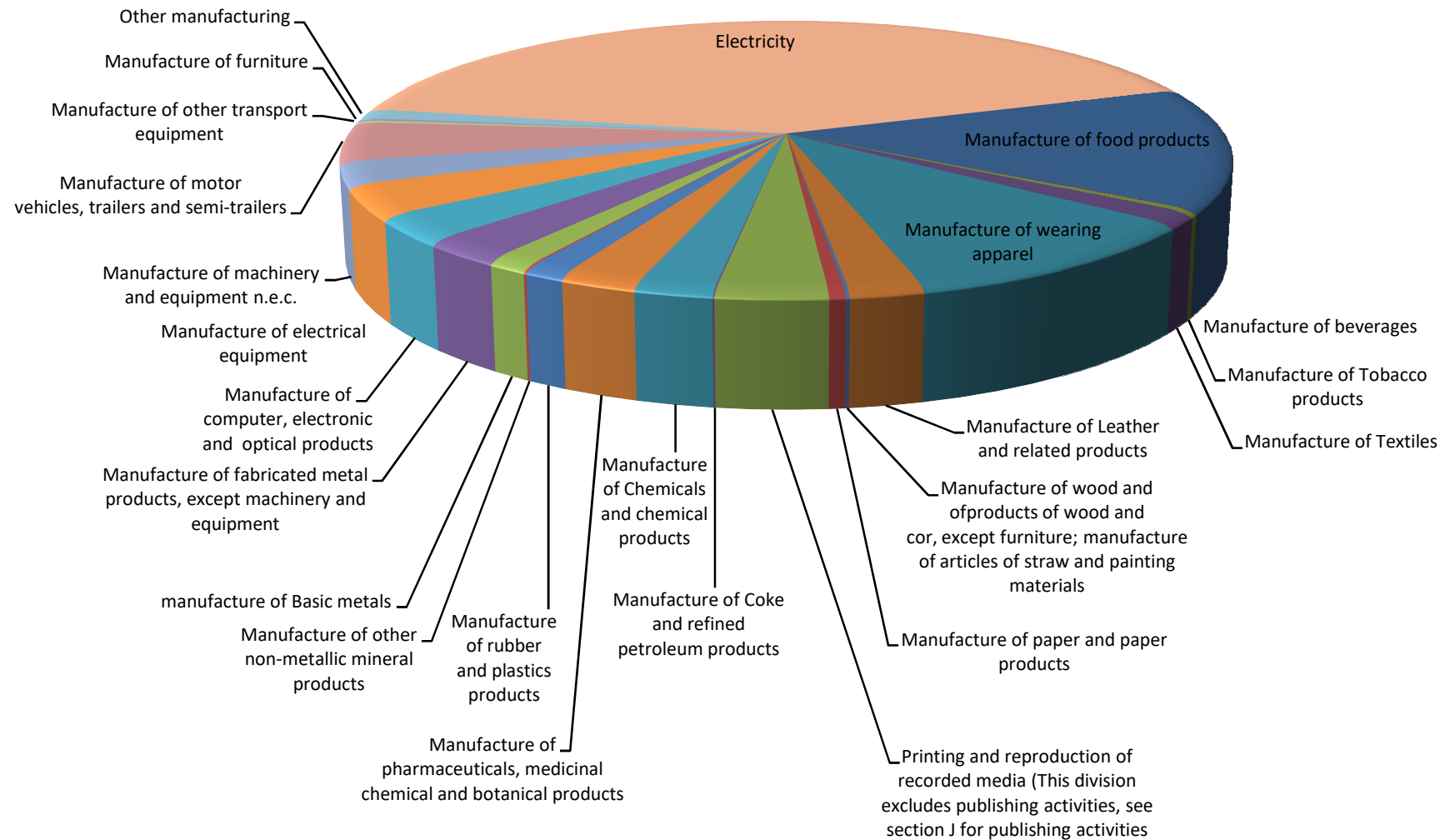
Where  $P_{ic}$  = Production of  $i^{\text{th}}$  item in the current month.

$P_{io}$  = Production of the  $i^{\text{th}}$  item in the base month

## CHAPTER-THREE

### A BRIEF ANALYSIS OF IIP

For the purpose of compiling the index, the industrial sector has been divided into manufacturing and electricity sectors with the weights of 586.1 and 413.9 respectively out of total weight 1000 with base year 2011-12. The manufacturing sector has further, been sub-divided into 23 major industrial groups at 2 digit level of NIC-2008.

#### **SALIENT FEATURES:**

Average Annual Index of Industrial Production, 2020-21 has indicated a decline of 10.45% in IIP as compared to the previous year i.e. 2019-20. During the year 2019-20 IIP was estimated at 157.34 which decreased to 140.91 in the year 2020-21. It is evident from the Statement 3.1 that both the manufacturing and electricity sector have declined in IIP by 10.45% and 12.26% per cent respectively. In the manufacturing sector IIP has decreased from 156.66 in 2019-20 to 142.32 in 2020-21. On the other hand, electricity sector has also shown decrease in IIP from 158.31 to 138.90. Detail of index by sectors for the year 2020-21 is depicted in Statement 3.1.

As indicated above, General Index has decreased by 10.45 % from 157.34 in the year 2019-20 to 140.91 in the year 2020-21. Same trend has also been observed both in the manufacturing and electricity sectors.

Out of 23 groups of manufacturing sector at NIC-2 digit level, 5 groups have shown increase in IIP in the year 2020-21 as compared to 2019-20. These 5 groups, namely, Manufacture of motor vehicles, trailers and semi-trailers (NIC-29), Manufacture of machinery and equipment n.e.c. (NIC-28), Manufacture of food products (NIC 10), Manufacture of furniture (NIC-31) and Manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and painting materials (NIC-16).

On the contrary, 18 sectors at NIC 2-digit level have exhibited decline in IIP in the year 2020-21 as compared to 2019-20. Many of them have reported zero production in the year 2020-21. Out of these 18 groups, 3 groups, namely, Manufacture of wearing apparel (NIC-14), Manufacture of computer, electronic and optical products (NIC-26) and Manufacture of fabricated metal products, except machinery and equipment (NIC-25) had the major negative contribution in IIP of manufacturing sector. Detail of month wise IIP for the last three years starting from 2018-19 is shown in Statement 3.4.

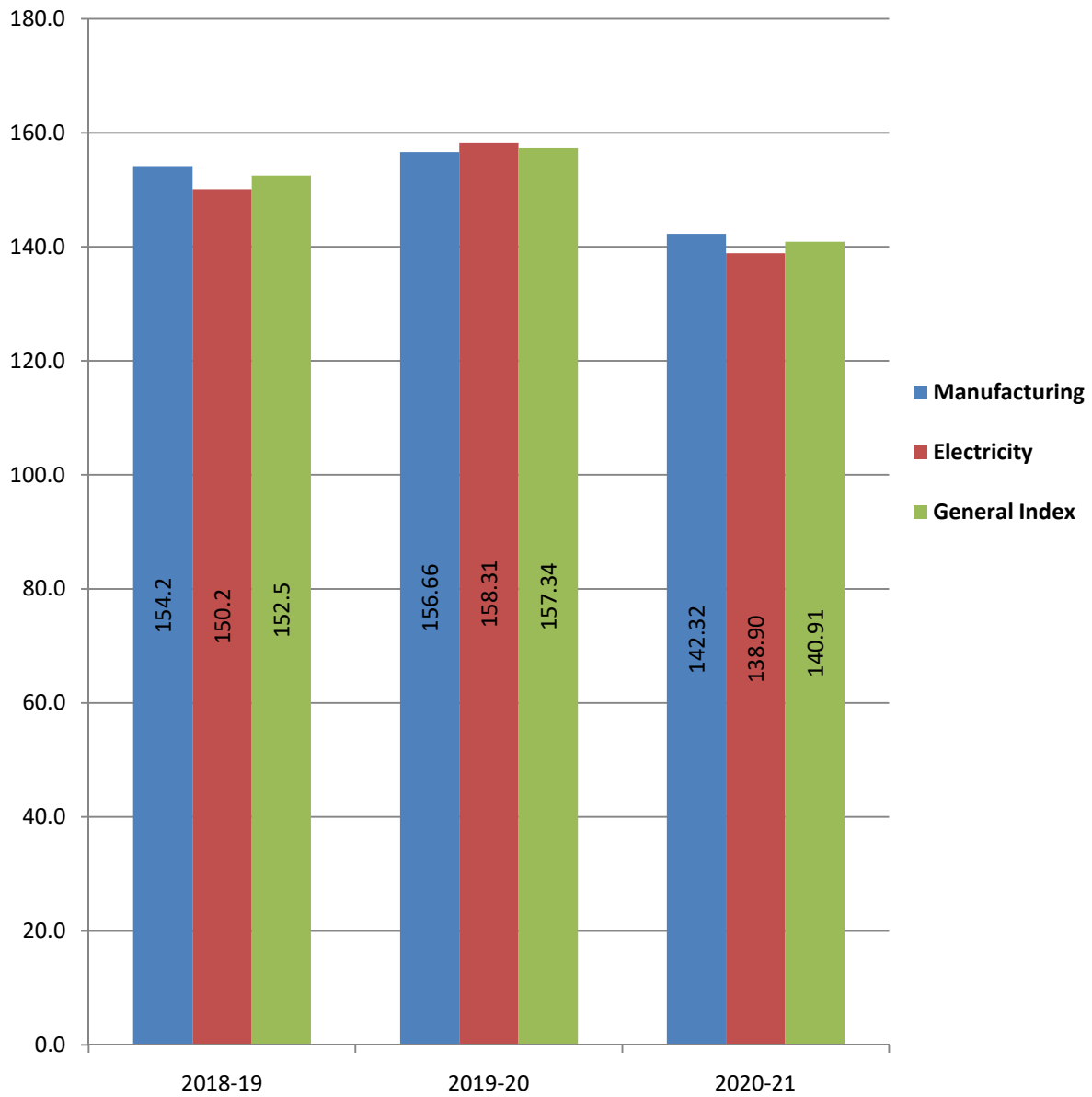

As indicated in Statement 3.1.1, the All India indices of industrial production of Manufacturing sector and Electricity Sector 2020-21 records 9.57% and 0.50% decrease respectively as compared to indices of 2019-20. All India IIP of 2020-21 refers that there was about 8.45 % decline in overall General Index as compared to IIP of 2019-20. The declining trend in IIP for the year 2020-21 in comparison with 2019-20 in Delhi and All India are almost same for Manufacturing Sector.

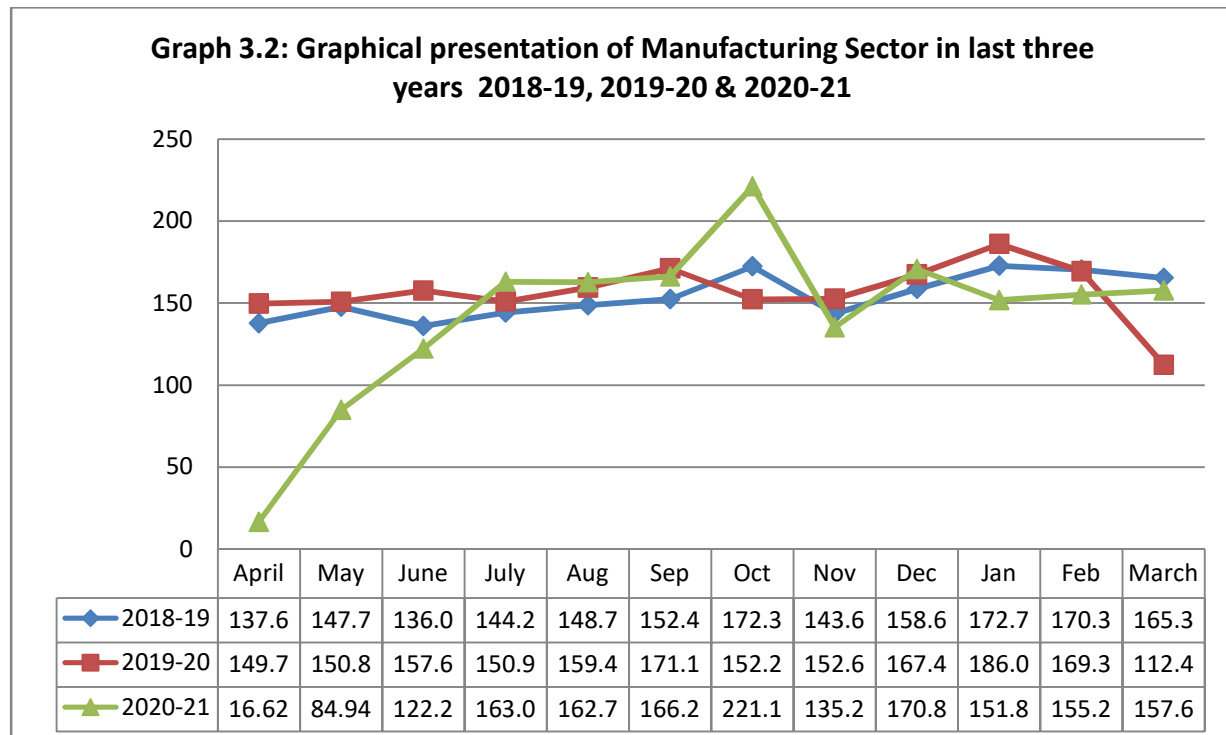

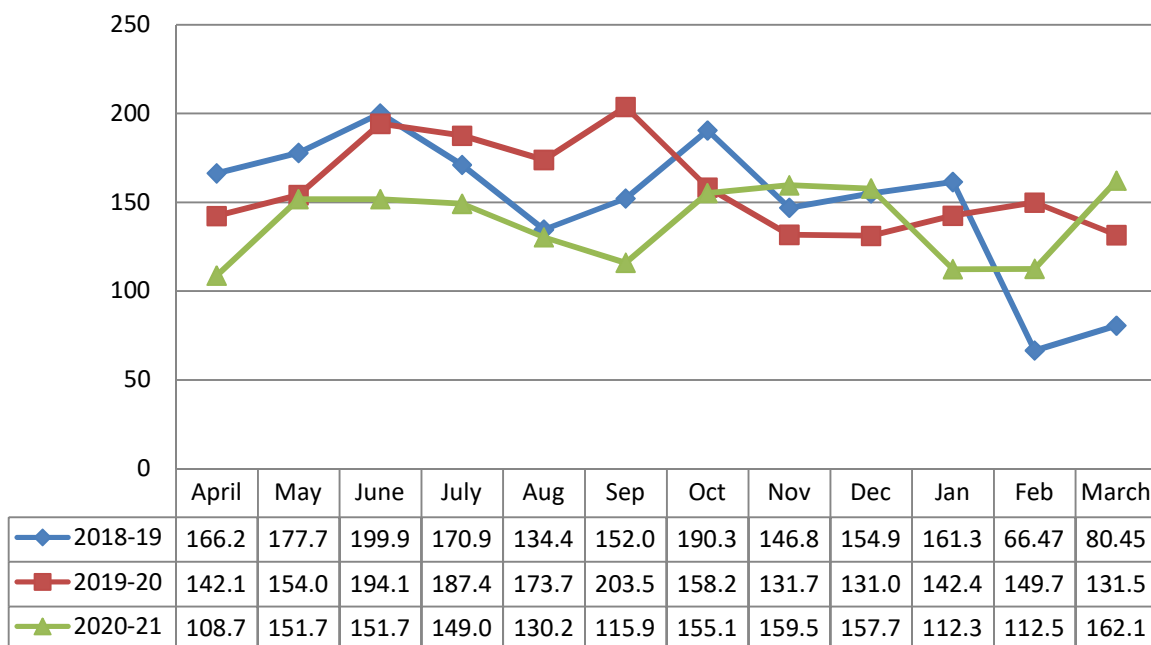

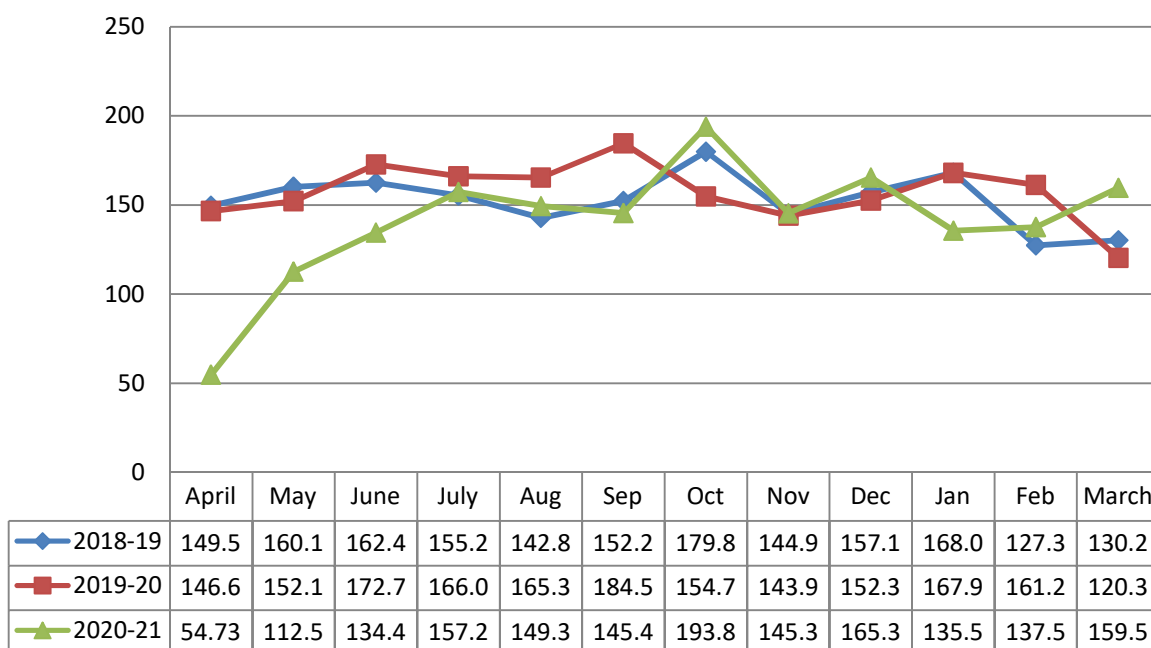

## CHAPTER – IV

### USE BASED INDEX OF INDUSTRIAL PRODUCTION

Different industries have been classified on the basis of uses of items produced by these industries to capture the performance of different industrial groups. On the analogy of the use based classification adopted by Central Statistics Office, item basket of production has been classified into four main groups. These groups consist of Primary goods, Capital goods, Intermediate goods and Consumer goods. Consumer goods are further sub divided into Consumer durable goods and Consumer non-durable goods. Use based monthly index of Industrial Production provides the information regarding the performance of above mentioned industries which are classified according to their product usage.

Weighting diagram for use based categories reveals that Primary goods industry is predominant in the industrial production of NCT of Delhi and covers 43.22% of total production, followed by consumer goods of 38.37% with a share of 19.90% for consumer non durable goods and 18.47% for consumer durable goods. Share of Capital goods and Intermediary goods industries are 16.35% and 2.06 % respectively when weights are allocated on the basis of their productions in the base year.

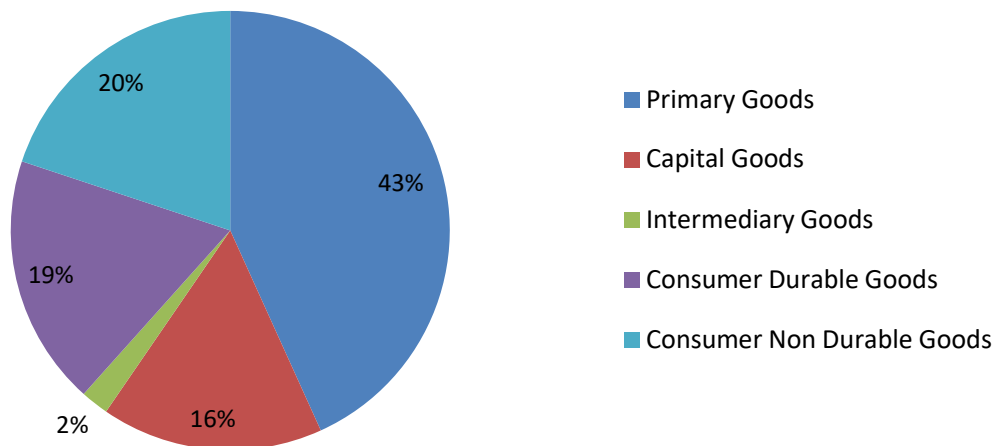
Performance of industrial groups as per Use Based Classification for the year 2020-21 has been presented in Statement 4.1. It is evident that in the year 2020-21, only one group, namely, Intermediary goods has exhibited growth in production index by 23.13% from the previous year, i.e. 2019-20. On the other hand, Primary Goods, Capital goods, Consumer Durable Goods and Consumer non durable Goods are showing decrease in production index by 11.98%, 23.90%, 22.71% and 1.88% respectively in the year 2020-21. Detail of index of Industrial Production with the Use-Based classification is depicted in Statement 4.1 for the consecutive three years starting from 2018-19.

Weighting diagrams and annual average indices have also been depicted through graphical representation in the following pages.

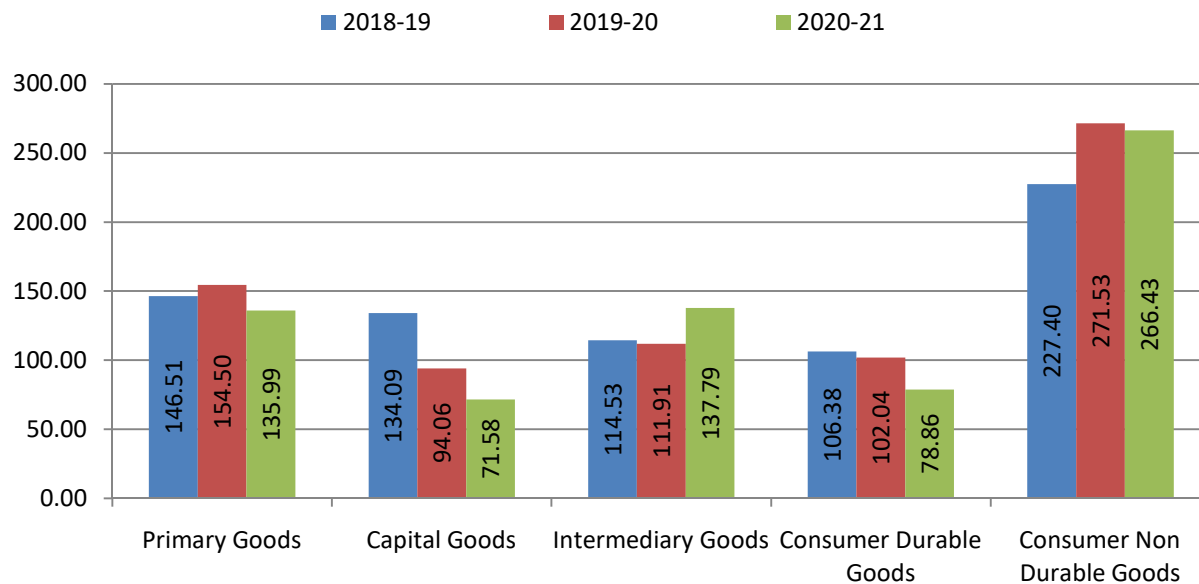
