An average person in Delhi now earns over Rs 3 lakh a year. three times the national average. This is because Delhi's GDP has consistently grown faster than India's (8.8% as against country's 7.1% in 2016-17). P6


### प्रति व्यक्ति आय में पहले स्थान पर है राजधानी





### Delhi's per capita income crosses ₹3 lakh with an 11% increase

NEW DELHI: Delhi continues to hold the top position among all states and union territories with respect to per capita income. The advance estimate of per capita income of Delhi at current prices during 2016-17 is estimated at ₹3,03,073 against ₹2,73,618 during

Deputy chief minister Manish Sisodia released the Estimates of State Domestic Product - 2016-17 that showed a 10.76% increase in the per capita income of Delhiites on a year-on-year basis.

"This reveals an annual growth of 10.76% over the previous year as against 10.2% growth at the national level. Among all states and UTs, Delhi ranks first. Goa is on the second spot and Chandigarh stood third. The per capita income of Delhi is nearly three times higher than the national average of ₹103,818 for the year 2016-17," a government statement said.

The report also revealed a continued double digit growth in the gross state domestic product (GSDP) of Delhi, which is estimated at ₹6,22,385 crore in 2016-17, registering a growth of

"The GSDP in Delhi at the current prices for 2016-17 is estimated at ₹6,22,385 crore against ₹5,51,963 crore in 2015-16, registering a growth of 12.76%. The real growth in GSDP at constant prices in Delhi during 2016-17, is 8.26% as compared to 7.1% at the national level," the statement

The contribution of Delhi in total GDP (at current prices) at the national level is 4.08% as compared to 1.4% share in the population of the country, it said.

## Delhi's GSDP estimated to go up by 12%

Deputy CM Manish Sisodia releases figures for Gross State Domestic Product

The Capital's Gross State Domestic Product (GSDP) at current prices is estimated to grow by over 12% from ₹5.51 lakh crore in 2015-16 to ₹6.22 lakh crore in 2016-17, according to a report released by Delhi Deputy Chief Minister Manish Sisodia on Monday.


The estimates of the State domestic product of Delhi for 2016-17 showed that the Capital had bested several bigger States, including Madhya Pradesh, Punjab and Haryana. As per the report, while the GSDP at current prices was estimated to grow by 12.76%, the GSDP at constant prices was estimated to increase by 8.26% from 2015-16 to 2016-17.

#### Big contributor

In comparison, the national growth rate was 7.1%.

Delhi also contributed 4.08% to the national GDP at current prices, while the population of the Capital was 1.4% of the total population of the country.

Referring to the report,



which was first tabled in the Delhi Assembly in March, Mr. Sisodia said that the share of the tertiary sector in Delhi's Gross State Value Added in 2016-17 was estimated at 82.26%, followed by the secondary sector at 14.84% and primary sector at 2.90%.

The sector with the biggest contribution with a 29.81% share was real estate, ownership of dwellings and professional services.

Financial services, hotels and restaurants, manufacturing and construction accounted for 14.83%, 11.69%, 8.41%

and 4.02%, respectively.

In addition, Delhi's per capita income was estimated to be ₹3.03 lakh in 2016-17, up by 10.76% from ₹2.73 lakh in 2015-16, making it the highest in India. In comparison, the national per capita income in 2016-17 was ₹1.03 lakh.



Advance estimates for 2016-17 show that Delhi's per capita income (net state domestic product) has crossed Rs 3 lakh in 2016-17, which is almost three times the national average.

Delhi's per capita income growth, which had fallen below 10 per cent in 2014-15 and 2015-16 (in current prices), grew by 10.8 per cent in 2016-17, marginally higher than the all India average growth of 10.2 per cent.

Interestingly, data from Niti Aayog shows that in 2013-14 (the last year for which comparable estimates are available), per capita income (NSDP) of Goa was higher than that of Delhi at Rs 224,138 compared to Rs 212,219

But it has now been reported that Delhi now ranks first, followed by Goa and Chandigarh. This implies that Goa's growth rate has slowed down in the past few years.

The Gross State Domestic Product (GSDP) of Delhi grew by 12.61 per cent in 2016-17 as compared to the previous year.

Manish Sisodia, Deputy Chief Minister of Delhi, while releasing the Estimates of State Domestic Product 2016-17 on Monday said, "The economy of Delhi is going forward on the path of sustainable growth in a considerable manner. The rank of Delhi as per the estimates of GSDP is much better than some of the states such as Madhya Pradesh, Bihar, Punjab, Haryana and Odisha."

The estimates have been prepared with the new base year 2011-12. The GSDP, representing the value of all the services and goods produced within the state, is an important indicator to measure the economy.

The GSDP in Delhi at the current prices for the year 2016-17 is estimated at Rs 6,22,385 crore against Rs 5,51,963 crore in 2015-16, registering a growth of 12.76 per cent, Sisodia said.

The real growth in GSDP at constant prices in Delhi during 2016-17 is 8.26 per cent as compared to 7.1 per cent at the national level.

The report showed that Delhi's contribution in the country's GDP (at current prices) was 4.08 per cent even though its population share is just 1.4 per cent of the total population of the country.

The estimates, brought out by the Delhi government's Directorate of Economics and Statistics, have been prepared with the new base year 2011-12.

The share of service sector in Delhi's economy is about 82.26 per cent, followed by the secondary sector 14.84 per cent and the primary sector 2.90 per cent, he added.

According to the Estimates of State Domestic Product the Per Capita Income of Delhi has been fast increasing year by year.
